

**SELECTION NOTICE FGV/EESP – NATIONAL PROGRAM OF POST-DOCTORATE CAPES
(Ordinance nº86/2013)
POST-DOCTORATE SCHOLARSHIP IN ECONOMICS 2018**

The PHD Program in Economics of São Paulo from Fundação Fundação Getulio Vargas – FGV/EESP - open selective process for candidates to (1) vacancy to Post-Doctorate, in according to the Ordinance CAPES nº86/2013, that regulates the National Program of Post-Doctorate PNPd/CAPES.

REQUIREMENTS AND ATRIBUTIONS FOR CANDIDATES AND SCHOLARSHIPS

From candidates to fellow requires:

I – Having title of PH.D when the scholarship deployment, obtained in courses evaluated by CAPES and recognized by CNE/MEC. In case of certificate obtained in abroad institution, must have the recognition or revalidation by Brazilian institution recognized by MEC or approved your approval of your equivalence to granted by FGV/EESP;

II – Providing updated curriculum at Plataforma Lattes of CNPq or, if foreign, curriculum with historic register of patents and/or publication of cientific work and technologic of impact and/or awards of academic merit, and other professionals activities and academics relevants;

IV – Don't be retiree or be in similar position;

V – The candidate can enroll in one of following modalities:

- a) being brazilian or foreign resident in Brasil portador of temporary visa, without employment;
- b) being foreign, resident abroad, without employment;
- c) being professor or researchers in country with employment in higher education institutions or public research institutions.

§ 1º Resident foreign candidates abroad must prove resident adress when submitt the application.

§ 2º Substitute teachers may be approved in the form "a" of item V, with no prejudice to their teaching activities, after analysis and approval of the Graduate Program.

§ 3º The candidates approval in the mode "c" of item V must provide clearance for attesting the home institution for a period compatible with the deadline of scholarship.

§ 4º The candidates approved in the form "c" of item V may not hold the post-doctoral stage at the same institution with have employment.

From fellow requires:

I - Elaborate Annual Activity Report to be submitted to the Graduate Program and forward Final

Report within sixty (60) days after the end of the respective scholarship;

II – Dedicate to courses activities;

III– Return to CAPES irregularly funds received, when determined non-compliance with the rules of PNPd, unless motivated by unforeseeable circumstances, force majeure, circumstances others their will or serious illness duly confirmed and substantiated. The evaluation of these situations is subject to analysis and deliberation by the Executive Board of CAPES by reasoned order.

DURATION OF SCHOLARSHIPS

For fellows approved at the modalities "a" and "b" of item V, the scholarship duration period shall be twelve months and may be renewed annually up to a maximum of sixty (60) months.

For successful candidates at the form "c" of item V, the maximum period of the scholarship duration will be 12 months, without possibility of renewal.

GENERAL INFORMATIONS

The PNPd/CAPES scholarship covers two different financial contributions: a monthly stipend and payment of annual funding resources.

If there is availability of resources to costing, these will be passed to the scholarships, this budget is intended to support research activities, such as participation in events for the presentation of work/research.

The scholarship consists of the payment of fees in the amount of R\$ 4.100.00 (four thousand and one hundred reais) during the entire term of the grant. It is forbidden accumulation of the scholarship with any other form or development agency.

The applicants must apply for registration in the selection process to the Coordinator of the Graduate Program in Economics by email cmcd.economia@fgv.br. After the expression of interest, will be sent the list of documents required to effect the registration.

Initial of Post-Doctorate Program: January 1th, 2018
